1/1/2010 - LIMITED WAIVER OF FILING FEES FOR EXPUNCTIONS

Requires that the fees under Subsection (a) (relating to requiring a petitioner seeking expunction of a criminal record to pay certain fees) be waived if the petitioner seeks expunction of a criminal record that relates to an arrest for an offense of which the person was acquitted, other than an acquittal for an offense described by Article 55.01(c) (relating to prohibiting expunction of records for certain persons) AND the petition for expunction is filed not later than the 30th day after the date of the acquittal.
